Step 4 – Send Insurance Requirement Info to Your Agent:

Your boat insurance company must add two HOA associations as additional insured's on your policy and send evidence to the HOAs as indicated on the enclosed "Vessel Additional Named Insured's Request Form." Please forward the form to your boat insurance agent. If desired, the form can be downloaded from RDHOADOCKS.COM or LAGUNADOCK.COM and e-mailed to your agent. The HOA must receive this information from your insurance company within 30-days of first mooring of the vessel. *NOTE: (This is not optional but is a condition of having a vessel in this harbor).*
